

Invest in Me Week: £20 Junior ISA Promotion

For every eligible person that joins GoHenry during the promotional period and fulfills the Qualifying Conditions, we'll offer a free trial period of 1 month and a £20 contribution towards your child's GoHenry Junior ISA. The free trial means that when the parent account and child card are activated, the Monthly Membership Fee (£3.99 for Everyday, £5.99 for Plus, or £9.99 for Max) will not be charged for the first month. This offer is available from 00:01 BST on 21st April 2026 to 23:59 BST on 5th May 2026 (the "Promotional Period"). From time to time we may offer specific promotions which may include different promotions and offers. This offer may not be used in conjunction with any of our other promotions or offers.

Terms and conditions:

- This offer is limited to new customers signing up for a GoHenry account during the Promotional Period, who:
 - activate their parent account and child card; and
 - for each applicable child open a GoHenry Junior ISA; and
 - meet our Eligibility Criteria (as defined below) (the "**Qualifying Conditions**").

Please note: All Qualifying Conditions must be fulfilled within thirty (30) days of the end of the Promotional Period.

- This offer provides eligible new GoHenry customers with a free trial period of 1 month and a £20 Junior ISA contribution for each child once they fulfill the Qualifying Conditions. **The £20 award for each child will be issued within fourteen (14) days of all the Qualifying Conditions being fulfilled.** The free trial means we will not charge the Monthly Membership Fee for the first month after activation.
- This offer is valid from 00:01 BST on 21st April 2026 to 23:59 BST on 5th May 2026.
- This offer is open to UK residents aged 18 or above that have passed GoHenry's required security checks for account activation (subject to GoHenry's regulatory requirements) ("**Eligibility Criteria**").
- A GoHenry parent account is deemed to be 'active' once a minimum of £10.00 has been loaded to the parent account by the parent and remains active provided the account is not closed. The minimum £10 load is credit that either sits in the parent account or is

transferred to the child's card, which can be withdrawn if the user cancels the account.

- GoHenry will not charge the Monthly Membership Fee for as long as the GoHenry account is not active, however, the parent will not be able to use functions that require money (i.e. paying pocket money, buying custom cards, etc.) if the account has not been activated.
- When the initial free trial period of 1 month ends, the Monthly Membership Fee will be deducted automatically from the available balance on your Parent Account. Please be aware that GoHenry membership fees are recurring/continuous authority transactions and your monthly membership fees will be debited on the same day of the month (or as close to it) as the day you activated your Account.
