Monthly contributions set up between 1-5 April 2022, will be eligible provided a successful payment is taken on time the following month. Where payment is unsuccessful or otherwise delayed, the entry into the Prize Draw will be voided.
10. Entries into this Prize Draw will be voided where the GoHenry Junior ISA is transferred to another provider before 13 May 2022.
11. GoHenry will contact the winning Parent via email, confirming the value of the Prize, confirm their available Junior ISA allowance and, if they have more than one GoHenry Junior ISA, their preferred method for distributing the Prize.
12. HMRC rules allow up to £9,000 to be paid into a Junior ISA in the 2022/2023 tax year. Where the Prize results in this limit being exceeded, GoHenry will discuss how to allocate the balance of the Prize with the parent.

18. Furthermore, the Parent has sole responsibility for ensuring that their Child's annual Junior ISA contribution limit is not exceeded. For the avoidance of doubt, this includes any Junior Cash ISA in the Child's name.
