GoHenry Cookie Policy: The Short & Sweet Version

Before diving into the details, here is the baseline of how we handle your data:

- You are in control: We only use optional cookies if you say it's okay.
- Your privacy matters: You can change your mind and adjust your settings at any time.
- We're transparent: Want to know exactly how we use your data? Our full [Privacy Notice](#) has you covered.

1. What actually is a cookie?

Think of a cookie as a tiny digital memory chip. When you visit our website or app, a small text file is saved to your browser or device.

The next time you visit us, these chips help our system recognise your device. This is how we remember your preferences, separate your experience from other users, and make sure our content fits what you need.

We also use "pixel tags" (sometimes called web beacons or clear GIFs). These are tiny, invisible graphics placed on web pages or in our emails. They help us see if you've opened an email or interacted with certain content, allowing us to send you more relevant updates

An SDK is essentially the app version of a cookie. It does the exact same job, but inside our mobile app instead of on a website. It helps us remember your settings, keep the app running smoothly, and understand how the app is being used so we can make it better for your family.

2. The different types of cookies we use

Cookies do a lot of heavy lifting behind the scenes to make your GoHenry experience smooth. They generally fall into two categories based on who puts them there:

- First-party cookies: These are set directly by GoHenry.
- Third-party cookies: These are placed by trusted partners working on our behalf to help us with analytics, performance, and relevant advertising.

How long do they stay?

- Session cookies: These are temporary. They do their job while your browser is open and delete themselves the second you close it.
- Permanent cookies: These stay on your device after you close your browser. They help us recognise you when you come back, so you don't have to reset your preferences every time.

3. The four categories of cookies

To keep things clear, we group our cookies into four straightforward buckets.

Please note: The targeting cookies below apply to our marketing website only. Our mobile app does not use behavioural targeting cookies and does not track you for ad targeting purposes. See the 'SDKs and similar technologies used in-app' section below for how the app handles advertising measurement

Every cookie we or our partners use falls into one of these:

Cookie Type	What it does	Why we use it
Essential	The absolute basics required to keep our site running safely and securely.	Without these, the website simply wouldn't work.
Functionality	Remembers choices you make (like your username or language).	Saves you time and customises your experience.
Analytics & Performance	Tracks how visitors move around the site and where they might get stuck.	Helps us spot bugs and improve our platform for everyone.
Targeting & Advertising	Keeps track of the pages you visit and links you follow.	Ensures the updates or ads you see from us actually match your interests.

4. What about in-app tracking?

We carry the same privacy promises over to our GoHenry mobile app. Just like on our website, we use certain tools to understand how you interact with our app so we can keep making it better.

If you choose to turn off tracking, the app will still work completely normally for all your payments and account features. We simply switch off our internal analytics tools and advertising measurement behind the scenes.

If you keep tracking turned on, we use it to understand feature usage trends, product adoption, and signup funnel conversion rates to help us design better app updates. It helps us see which features

you and your teens enjoy, allows us to fix bugs much faster, and ensures the tips and updates you see match your interests. Please note: These analytics are only enabled if adults and teens actively consent. Analytics tracking is turned off by default for children under 13.

We use Adjust and Firebase to measure advertising campaign performance by sharing event signals (app activation, checkout, registration), device ID, and hashed email. Adjust shares with Google, Apple Ads, Meta and TikTok; Firebase shares with Google Ads only. This data sharing is only enabled for adult users who have accepted the tracking cookies and excludes transaction details or sensitive payment information. You can change your mind anytime in your settings. We don't use this data to target ads to you, but Google, Apple Ads, Meta, and TikTok may use it for their own campaign optimisation and audience building.

A note for iOS users: If you are on an Apple device, you will also see Apple's standard App Tracking Transparency (ATT) prompt. Your privacy choices within the GoHenry app come first, and Apple's prompt acts as an extra layer of privacy control on top of it.

How to manage or delete cookies

We use cookies to make sure our website and app work smoothly for you and your family. Some cookies are essential. We can't run the website without them. Others are optional, meaning we only use them if you agree, and you can change your mind at any time.

When you visit our site, you'll see a notice letting you choose your cookie preferences. You have total control over these optional settings, but please keep in mind that turning them off might affect how the site works. For example, you might have to re-enter information, or you won't see personalised content.

Managing your preferences

- In the app: You can control non-essential tracking at any time via your app settings page.
- On the web: You can update your preferences right [here](#) or change your settings directly in your internet browser.

Most browsers let you choose your level of privacy. This allows you to:

- See your stored cookies and delete them one by one.
- Block cookies from third parties or specific websites.
- Block all cookies from being set.
- Automatically delete all cookies when you close your browser.

Good to know: If you clear or block all cookies, website functionality will be limited, and any preferences you previously saved (like opting out) will be reset.

Amplitude Experiment	Decides which version of a feature a user sees (A/B tests)
Firebase Analytics	Google's analytics for app usage and screen views. Tracks conversion events (app activation, checkout, registration, etc.) and shares event signals with Google Ads for campaign measurement and optimisation, using device identifiers and hashed email for user identification.
Firebase Performance	Measures how fast network requests are

Adjust / Install Referrer	Tracks conversion events (app activation, checkout, registration, etc.) and shares event signals with Google, Apple Ads, Meta & TikTok for campaign measurement and optimisation, using device identifiers and hashed email for user identification.
Customer.io	Tracks engagement, links app activity to email/ push campaigns, supports in-app messages. Records when a user opens a link from a CIO email
Firebase Crashlytics	Sends crash and error reports; can include a user ID after login
