

PTA Prize Draw 2026

Terms and Conditions

1. This Prize Draw is for the chance for one PTA to win a cash prize of £3,000 (the “**Prize**”)
2. This Prize Draw will be open from 00:00 BST on 15th June 2026 until 23:59 BST on 24th June 2026 (the “**Entry Period**”).
3. To enter this Prize Draw, the PTA must be signed up to GoHenry’s PTA programme. The PTA will receive one entry into the Prize Draw for every eligible new GoHenry customer referred to GoHenry through the PTA’s landing page during the Entry Period, provided the Qualifying Conditions have been met.
